ASSIGNMENT OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This ASSIGNMENT OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Assignment”), dated as of February 8, 2019, is by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as resigning Administrative Agent (as defined in the Credit Agreement described below, and in such capacity, the “Existing Agent”) and BANK OF AMERICA, N.A., in its capacity as successor Administrative Agent (in such capacity, the “Successor Agent”).

RECITALS:

WHEREAS, Brink’s Network, Incorporated, a Delaware corporation, as “Grantor”, and Existing Agent are parties to the intellectual property security agreement identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “Agreement”) pursuant to which Grantor granted a security interest in and to and lien upon the intellectual property identified in Schedule A; and

WHEREAS, pursuant to that certain First Amendment to Loan Documents, dated as of the date hereof, by and among the Existing Agent, the Successor Agent, the Grantor and certain other parties party thereto, the Existing Agent has resigned as Administrative Agent under that certain Credit Agreement, dated as of October 17, 2017, among The Brink’s Company, a Virginia corporation (the “Parent Borrower”), the Subsidiary Borrowers referred to therein, the Grantor and certain other Subsidiaries of the Parent Borrower, as Guarantors, the lenders party thereto (the “Lenders”) and the Existing Agent (as amended prior to the date hereof, the “Credit Agreement”), and the Successor Agent has been appointed as successor Administrative Agent thereunder.


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Existing Agent hereby assigns and transfers to the Successor Agent and its successors and assigns, all of its rights, title and interest as Administrative Agent in and to the Agreement and the security interests and liens granted thereby.


