TERMINATION OF TRADEMARK MORTGAGE

This Termination of Trademark Mortgage (“Termination”) is executed and effective as of this 15th day of February, 2019 by and between PNC Bank, National Association, successor to The Provident Bank, an Ohio banking corporation (“Bank”) and West Chester Holdings, Inc., an Ohio corporation formerly known as West Chester Marketing, Inc. 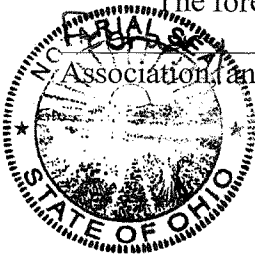

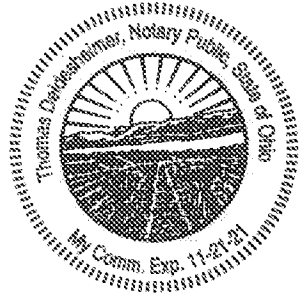
