## TERMINATION OF SECURITY INTEREST

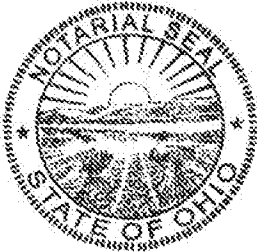

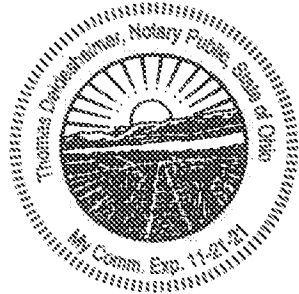
