TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made September 4, 2018 ("Effective Date") by and between Richard J. Land, Receiver ("Receiver") of 38 Studios, LLC, 38 Studios Baltimore LLC (d/b/a Big Huge Games), Mercury Project, LLC and Precision Jobs, LLC (collectively the "Assignor"), by the authority vested in the Receiver by Order of the Superior Court of the State of Rhode Island, Providence County in those administratively consolidated receivership proceedings captioned as Rhode Island Economic Development Corporation vs. 38 Studios, LLC, et al., P.B. No. 12-4095, P.B. No. 12-4096, P.B. No. 12-4097, P.B. No. 12-4098 ("Receivership Proceedings")- and THQ Nordic AB ("Assignee").

WHEREAS, the books and records of 38 Studios indicate that it owns certain trademarks and service marks, trademark and service mark applications and/or registrations and all common law rights associated therewith, which are listed in the attached **Schedule I** and incorporated herein ("Marks");

WHEREAS, the Assignor is the subject of the Receivership Proceedings and has agreed to assign the Marks, pursuant to the sale approved in the Receivership Proceedings, and to execute this Assignment subject to the terms and conditions of the Asset Purchase Agreement among the parties dated August 15, 2018 and the Receiver's Bill of Sale executed contemporaneously herewith;


WHEREAS, the Assignor desires to assign all of the rights, title and interests of the Assignor in and to the Marks together with the good will of the business symbolized by the Marks to the Assignee, and the Assignee has agreed to accept said assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Marks together with the good will of the business symbolized by the Marks, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.
2. Assignor hereby requests the U.S. Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.
3. This Assignment shall be governed by and interpreted in accordance with the laws of the State of Rhode Island, without giving effect to its choice of law provisions.
4. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of the signature page to this Assignment by facsimile or electronic mail (with signature visible) shall be as effective as delivery of a manually executed counterpart of this Assignment.


