RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

Date: February 20, 2019

WHEREAS, Total Defense, LLC (the “**Grantor**”) granted a security interest in and lien upon all of the Grantor’s right, title and interest in, to and under any and all of the IP Collateral (as defined in the Intellectual Property Security Agreement referred to below) to Varagon Capital Partners Agent, LLC, as administrative agent and collateral agent for the benefit of the Secured Parties under the Security Agreement (as defined below) (in such capacity, the “**Administrative Agent**”) as set forth in the Intellectual Property Security Agreement, dated as of October 9, 2018, by and between the Grantor and the Administrative Agent (the “**Intellectual Property Security Agreement**”), and that certain Guarantee and Collateral Agreement, dated as of October 5, 2017, by and among the Grantor, the other grantors from time to time party thereto and the Administrative Agent (as subsequently amended, restated or otherwise modified from time to time the “**Security Agreement**” and, together with the Intellectual Property Security Agreement, the “**Security Agreements**”);

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office with respect to Trademark Collateral (as defined in the Intellectual Property Security Agreement) on October 9, 2018 at Reel/Frame 006452/0740;

WHEREAS, Grantor has requested that the Administrative Agent release and reassign its security interest in the Trademark Collateral and the other IP Collateral, including the registered trademarks and pending applications for trademarks more fully identified in Schedule 1 annexed hereto and made a part hereof (including, without limitation, all goodwill associated therewith) (the “**Released Trademarks**”).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Without recourse or representation or warranty, express or implied, of any kind or nature whatsoever, (a) the Administrative Agent hereby releases, relinquishes and discharges any and all liens and security interests in and to all of the Grantor’s right, title and interest in, to and under the Trademark Collateral and the other IP Collateral, including, without limitation, the Released Trademarks, and (b) reassigns, regrants and reconveys to the Grantor any and all of Administrative Agent’s right, title and interests (if any) in, to and under the Trademark Collateral and the other IP Collateral, including, without limitation, the Released Trademarks, in each case granted pursuant to the Security Agreements.


2. The Administrative Agent hereby (a) authorizes the Grantor or its authorized representatives to record this Release of Security Interest in Intellectual Property (the “**Release**”) with the U.S. Patent and Trademark Office and (b) authorizes and requests that the U.S. Patent and Trademark Office note and record the existence of this Release hereby given, at the Grantor’s sole cost and expense.
