RELEASE OF SECURITY INTEREST IN  
TRADEMARKS, dated as of February 21, 2019 (this  
"Release"), by JPMORGAN CHASE BANK, N.A.  
("JPMorgan"), as Administrative Agent.

A. Reference is made to (i) the Credit Agreement dated as of October 31, 2018, (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Ta Chen International, Inc., a California corporation (the "Borrower"), the lenders from time to time party thereto and JPMorgan, as Administrative Agent (ii) the Guarantee and Collateral Agreement dated as of October 31, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Borrower, the other Subsidiary Loan Parties from time to time party thereto and JPMorgan, as Administrative Agent and (iii) the Trademark Security Agreement dated as of October 31, 2018, among the Borrower, the other Subsidiary Loan Parties from time to time party thereto and JPMorgan, as Administrative Agent (together with the Collateral Agreement, the "Security Agreements").

B. Pursuant to the Security Agreements, the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantors in, among other things, the trademarks set forth on Schedule I hereto (the "Trademark Collateral"), which security interests were recorded with the United States Patent & Trademark Office on November 13, 2018 at Reel/Frame 6480/0417.

C. Pursuant to the Payoff Letter dated as of December 20, 2018, between the Borrower and the Administrative Agent, the Administrative Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the Secured Parties, does hereby state as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the applicable Security Agreement.

SECTION 2. Release. The Administrative Agent, on behalf of itself, the Secured Parties and their permitted successors and assigns, does hereby terminate, release, relinquish and discharge its and their security interest granted under the Security Agreements in the Trademark Collateral and any right, title or interest granted under the Security Agreements it has in the Trademark Collateral shall hereby cease and become void. This Release is made without representation or warranty by, or recourse to the Administrative Agent or any other Secured Party.


