## CORRECTIVE TRADEMARK ASSIGNMENT

THIS CORRECTIVE TRADEMARK ASSIGNMENT ("Corrective Trademark Assignment"), is made by and between My Patriot Supply, an Indiana sole proprietorship owned by Matthew Parker ("Assignor") and Patriot Supply Store, Inc., a Nevada corporation ("Assignee") and is effective as of November 19, 2013.

WHEREAS, Assignor assigned the trademark and trademark registration set forth on Exhibit 1 hereto (the "Trademark") and attached as Exhibit 2, but inadvertently listed the incorrect Assignor (*See Declaration in Exhibit 3*); and

WHEREAS, Assignor assigned its entire right, title, and interest in the Trademark to Assignee in connection with a corporate reorganization on November 19, 2013;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties wish to confirm the transfer of ownership as follows:

1. In connection with the transfer of the portion of the business to which the Trademark pertains, Assignor hereby transferred, conveyed, assigned, and set over unto Assignee, and its successors and assigns, Assignor's entire right, title and interest in and to the Trademark, including, without limitation, all registrations and applications therefor and the right to apply for and register the Trademark, in the United States of America and all foreign countries, together with the goodwill of Assignor's business in which the Trademark was used and symbolized by the Trademark, all common law and statutory rights related thereto, all rights of renewal and extension, and the right to sue and recover for damages and profits for past infringements thereof, with such assignment effective as of November 19, 2013.

2 This Corrective Trademark Assignment inured to the benefit of and was binding upon Assignee and Assignor and their respective successors and assigns. This Corrective Trademark Assignment may be executed in one or more counterparts, all of which will be considered one and the same agreement and will become effective when one or more counterparts have been signed by each of the parties and delivered to the other party, it being understood that all parties need not sign the same counterpart. Any such signature page will be effective as a counterpart signature page hereto without regard to page, document or version numbers or other identifying information thereon, which are for convenience of reference only. This Corrective Trademark Assignment may be executed by facsimile or .PDF signature, and a facsimile or .PDF signature will constitute an original signature for all purposes.

I, Matthew Parker (AKA Matthew Redhawk), being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements and the like may jeopardize the validity of this document or any registration resulting therefrom, declares as follows:

1. I am the CEO of Patriot Supply Store, Inc. ("Registrant") and I am authorized to execute this declaration on its behalf.
2. In my position as CEO of Registrant, I am familiar with Registrant's corporate structure and use and ownership of the PATRIOT SEEDS mark as designated in U.S. Reg. No. 4,872,598.
3. On March 11, 2013, My Patriot Supply filed U.S. Application Serial No. 85/872,190 for PATRIOT SEEDS.
4. At the time of filing, My Patriot Supply was a sole proprietorship organized under the laws of the State of Indiana.
5. At the time of filing, Matthew Parker, a U.S. citizen, was the sole owner of My Patriot Supply.
6. On November 19, 2013, Matthew Parker and My Patriot Supply assigned ownership of U.S. Reg. No. 4,872,598 to Patriot Supply Store, Inc., a corporation organized under the laws of the State of Nevada.
7. On November 25, 2013, the assignment was recorded with the United States Patent and Trademark Office, as shown at Reel No. 5160/Frame No. 0012, where the original cover sheet and underlying assignment document can be found.
8. However, the recorded assignment document incorrectly identified Matthew Parker as Matt or Matthew Park.
9. Identifying Matthew Parker, the sole owner of My Patriot Supply, as Matt or Matthew Park in the assignment document was an inadvertent typographical error, made in good faith.
10. Matt or Matthew Park did not, and has never, owned or been associated with My Patriot Supply or U.S. Reg. No. 4,872,598.


