ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Agreement") is made and executed as of November 16, 2018 (the "Effective Date") by and between **JIBJAB MEDIA INC.**, a Delaware corporation ("Assignor"), and **JIBJAB CATAPULT CA LLC**, a Delaware limited liability company ("Assignee"). Capitalized terms used herein but not otherwise defined shall have the meanings assigned to such terms in the Asset Purchase Agreement, dated of even date herewith, by and between Assignee and Assignor (the "Purchase Agreement").

RECITALS

WHEREAS, pursuant to the Purchase Agreement, Assignor agrees to sell, transfer, convey, assign and deliver to Assignee all of Assignor's right, title and interest in all of the (i) Owned Intellectual Property, and (ii) IP Licenses, together with all remedies against past, present, and future infringements thereof; and

WHEREAS, Assignee wishes to acquire, and Assignor wishes to transfer all right, title and interest in and to the Owned Intellectual Property, including all rights to sue and recover for past infringement or wrongful use thereof everywhere in the world.

NOW, THEREFORE, for good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, Assignor and Assignee agree to be legally bound as follows:

AGREEMENT

1. **Assignment by Assignor.** As of the Effective Date, Assignor hereby, transfers, assigns and delivers to Assignee, its successors, assigns and legal representatives, and Assignee hereby purchases and acquires, all of Assignor's right, title and interest in and to the Owned Intellectual Property, together with the right to sue and obtain damages and equitable relief for past, present and future infringement, misappropriation, dilution or violation thereof. Assignor further transfers, assigns and delivers to Assignee, and Assignee hereby purchases and acquires the right to file and prosecute in its own name, wherever so permitted by Law, patent applications, including corresponding applications, based on any of the Owned Intellectual Property, and to claim priority to any of the Owned Intellectual Property pursuant to any Law. Assignor will cooperate to the extent reasonably necessary for Assignee to make any and all required filings to effectuate the transfer of the Owned Intellectual Property with any expenses associated therewith to be paid by Assignee. Assignor does not retain any ownership rights in the Owned Intellectual Property.

2. **Purchase Agreement.** This Agreement is made pursuant to the Purchase Agreement and is subject to all of the terms thereof, including without limitation, the representations, warranties, covenants and indemnification provisions therein. Nothing in this Agreement shall be deemed to limit, expand, amend, or otherwise modify any term or provision of the Purchase Agreement, including, without limitation any representation, warranty, covenant or indemnification provision set forth in the Purchase Agreement. In the event of any conflict between this Agreement and the Purchase Agreement, the terms of the Purchase Agreement shall govern.

3. **Governing Law.** This Agreement and the rights and duties of the parties under it shall be construed and enforced in accordance with the laws of the State of California, without giving effect to principles of conflicts of laws.

4. **Amendments.** This Agreement may not be amended, modified or supplemented except by an instrument in writing signed by appropriate and duly authorized representatives of both parties.

5. **Entire Agreement.** This Agreement (together with the Purchase Agreement) contains all of the terms, conditions and representations and warranties agreed upon or made by the parties relating to the subject matter of this Agreement and supersede all prior and contemporaneous agreements, negotiations, correspondence, undertakings and communications of the parties or their Representatives, oral or written, respecting such subject matter.

6. **Assignment.** No party shall be permitted to assign any of his its rights or delegate any of its obligations under this Agreement without the prior written consent of the other party. Notwithstanding the foregoing, the Assignee may assign its rights and obligations hereunder in connection with any change of control of the Assignee or sale or exclusive license of all or substantially all of the Assignee's assets This Agreement shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors or assigns.

7. **Headings.** The headings contained in this Agreement are intended solely for convenience and shall not affect the rights of the parties to this Agreement.

8. **Counterparts.** This Agreement may be executed in several counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement. The exchange of a fully executed Agreement (in counterparts or otherwise) by electronic transmission or facsimile shall be sufficient to bind the parties to the terms and conditions of this Agreement.

9. **Notice.** Notices shall be provided to the addresses and in the manner provided in the Purchase Agreement.






