## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (“**this Release**”) is made as of February 19, 2019 by **CORBEL STRUCTURED EQUITY PARTNERS, L.P.**, as administrative agent (“**Agent**”) for the benefit of the Purchasers, holder of a security interest in and to the Trademark Collateral, including, without limitation, the trademarks and trademark applications set forth on the attached Exhibit A and incorporated in this Release by reference. For good and valuable consideration, receipt of which is acknowledged, Agent, on behalf of itself and the Purchasers, releases and terminates all of their security interest in and to the Trademark Collateral, retransfers and reassigns to Borrower all right, title and interest in and to the Trademark Collateral and any other intellectual property, including any associated goodwill, which may be included in the Security Agreement, including, without limitation, the trademark applications and registrations set forth on the attached Exhibit A, and directs and authorizes the cancellation and termination of record of the Security Agreement.

This Release is authorized and joined in by **CORBEL STRUCTURED EQUITY PARTNERS PARALLEL, L.P.** and **CORBEL STRUCTURED EQUITY PARTNERS INTERNATIONAL, L.P.** who, together with the Agent, constitute the “**Required Purchasers**” pursuant to Section 8.10(a)(i)(C) of the Note Purchase Agreement.




