OF DEUXIÈME NOM INC.**

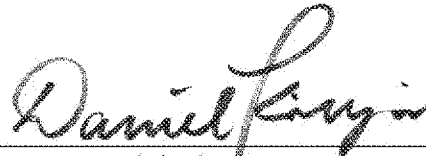
The undersigned, President of Deuxième Nom Inc., hereby certifies that:
