TRADEMARK ASSIGNMENT

WHEREAS, Pernod Ricard Denmark A/S, a joint stock company organized and existing under the laws of Denmark with a business address of Vesterbrogade 149 DK-1620 Copenhagen V, Denmark (hereinafter "Assignor"), is the sole owner of all rights, title, and interest in, under, and to the KIJABA trademark, Registration Number 0359556, (the "Mark");

WHEREAS, Assignor agreed to assign all right, title, and interest in, under, and to the Mark, together with the goodwill inherent therein, to United Beverages S.A., a joint stock company organized and existing under the laws of Poland with a business address of Plaska 24-36, 87-100 Toruń, Poland ("Assignee"), which is effective as of the date the Asset Purchase Agreement concluded between the Assignor and Assignee, under which Assignee acquired, among others, the rights to the Mark.

WHEREAS, the Asset Purchase Agreement between the Assignor and Assignee concluded, and the assignment thus took effect, on November 17, 2015; and

WHEREAS, Assignor wishes to acknowledge and confirm the assignment to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to Assignee and its successors and assigns, *nunc pro tunc*, effective as of November 17, 2015, all right, title, and interest in, under, and to the Mark, including all common law rights associated therewith and goodwill inherent therein, as well as the right to bring suit and recover damages for past infringements thereof.
