TRADEMARK ASSIGNMENT

This **TRADEMARK ASSIGNMENT** (the "Assignment"), dated as of November 30, 2018, is made and entered into by and between **BLAZE MEDIA LLC**, a Delaware limited liability company ("Assignee") and **THEBLAZE INC.**, a Delaware corporation ("Assignor"). All capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of the date hereof (the "Purchase Agreement"), to which Assignee and Assignor are parties, the Assignee has agreed to purchase substantially all of the assets of the Assignor;

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to sell, convey, assign, and transfer to Assignee all of Assignor's right, title, and interest in, to and under the Trademarks listed on Schedule A hereto, including all common law rights and goodwill thereto (collectively, the "Assigned Marks"); and

WHEREAS, pursuant to the Purchase Agreement, Assignor and Assignee have agreed to enter into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Conveyance. Assignor does hereby sell, convey, assign and transfer to Assignee all of Assignor's right, title and interest in and to the Assigned Marks, and all rights and goodwill corresponding to the Assigned Marks throughout the world, including the right to sue for past infringement of the Assigned Marks.

2. Recordation. Assignor hereby requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the Assigned Marks, and to issue any and all Assigned Marks to Assignee, as assignee of the entire right, title and interest in, to, and under the same. Assignee shall have the right to record this Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Assigned Marks.

3. No Modification. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend, expand upon or otherwise change any of the rights, remedies, or obligations of the Assignor and the Assignee under the Purchase Agreement and the Ancillary Documents. In the event of a conflict or inconsistency between the Purchase Agreement and this Assignment, the Purchase Agreement shall control and take precedence.

4. Successors and Assigns. This Assignment shall be binding upon, shall inure to the benefit of, and shall be enforceable by the Parties and their permitted successors and assigns.

5. Counterparts. This Assignment may be executed in counterparts, each of which shall be an original, and any one of which need not contain the signatures of more than one party, but all such counterparts taken together will constitute one and the same instrument, but all of which taken together shall constitute one and the same agreement. This Assignment may be executed and delivered by facsimile or portable document format (.PDF) transmission. This Assignment shall become effective when each party hereto shall have received a counterpart hereof signed by the other party hereto.

6. Headings. The subject headings of the paragraphs of this Assignment are included for convenience only and shall not affect the construction or interpretation of any of its provisions.

7. Governing Law. The internal law, without regard to conflicts of law principles, of the State of Delaware will govern all questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Assignment.
