
WHEREAS ETC has acquired substantially all of the assets of Euphoria, including its intellectual property;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledge, the Parties agree as follows:

This specifically includes the trademark listed in Schedule A together with any and all registration for such trademark and the goodwill of the business symbolized by the trademark listed in Schedule A.
2. ETC accepts this assignment.
3. The assignment is effective, *nunc pro tunc*, as of September 4, 2014.

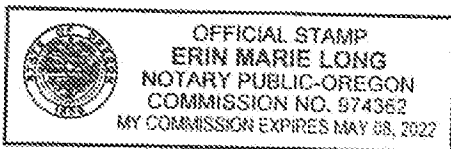

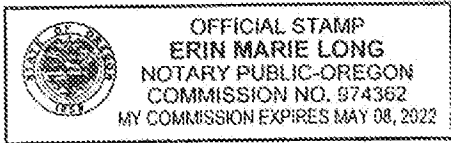
