**INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT**

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT, dated as of February 22, 2019 (the “*Intellectual Property Security Release*”), is executed and delivered by BANK OF AMERICA, N.A., (the “*Collateral Agent*”) for itself and as Administrative Agent for the Lenders (as defined in the Credit Agreement referenced below), in favor of DEAN INTELLECTUAL PROPERTY SERVICES II, INC. and DEAN FOODS COMPANY (each a “*Grantor*” and, collectively, the “*Grantors*”).

WHEREAS, the Grantors, the Lenders and the Collateral Agent have entered into a Credit Agreement dated March 26, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”);

WHEREAS, the Grantors and certain Subsidiaries of the Grantors have entered into a Pledge and Security Agreement dated March 26, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time, the “*Pledge and Security Agreement*”);

WHEREAS, pursuant to separate agreements between the Collateral Agent and each Grantor titled the Confirmatory Grant of Security Interest in United States Trademarks and each effective March 26, 2015 (the “*Trademark Confirmatory Grants*”) each of the Grantors granted to the Collateral Agent a security interest in (1) all of such Grantor’s right, title and interest in and to the Trademarks (as defined in the Pledge and Security Agreement) now owned or from time to time after the date hereof owned or acquired by such Grantor, including the Trademarks set forth on Schedule A attached hereto, together with (2) all proceeds and products of the Trademarks, (3) the goodwill associated with such Trademarks, and (4) all causes of action arising prior to or after the date hereof for infringement of the Trademarks or unfair competition regarding the same (the “*Trademark Collateral*”) in conjunction with the security interest granted to Collateral Agent under the Pledge and Security Agreement;

WHEREAS, the Trademark Confirmatory Grants were recorded with the United States Patent and Trademark Office on March 27, 2015 at Reel 5487/Frame 0276 and Reel 5487/Frame 0179;

WHEREAS, pursuant to separate agreements between the Collateral Agent and each Grantor titled the Confirmatory Grant of Security Interest in United States Patents and each effective March 26, 2015 (the “*Patent Confirmatory Grants*”) each of the Grantors granted to the Collateral Agent a security interest in (1) all of such Grantor’s right, title and interest in and to the Patents (as defined in the Pledge and Security Agreement) now owned or from time to time after the date hereof owned or acquired by the such Grantor, including the Patents set forth on Schedule B attached hereto, together with (2) all proceeds and products of the Patents, and (3) all causes of action arising prior to or after the date hereof for infringement of the Patents or unfair competition regarding the same (the “*Patent Collateral*”) in conjunction with the security interest granted to Collateral Agent under the Pledge and Security Agreement;

WHEREAS, the Patent Confirmatory Grants were recorded with the United States Patent and Trademark Office on March 27, 2015 at Reel 035278/Frame 0819 and Reel 035277/Frame 0651;



WHEREAS, pursuant to separate agreements between the Collateral Agent and each Grantor titled the Confirmatory Grant of Security Interest in United States Copyrights and each effective March 26, 2015 (the “**Copyright Confirmatory Grants**”) each of the Grantors granted to the Collateral Agent a security interest in (1) all of such Grantor’s right, title and interest in and to the Copyrights (as defined in the Pledge and Security Agreement) now owned or from time to time after the date hereof owned or acquired by the Grantors, including the Copyrights set forth on Schedule C attached hereto, together with (2) all proceeds of the Copyrights, and (3) all causes of action arising prior to or after the date hereof for infringement of the Copyrights (the “**Copyright Collateral**”, together with the Trademark Collateral and the Patent Collateral, the “**Intellectual Property Collateral**”) in conjunction with the security interest granted to Collateral Agent under the Pledge and Security Agreement;

WHEREAS, the Copyright Confirmatory Grants were recorded with the United States Copyright Office on March 31, 2015 at Volume 9919, Document 878 and Volume 9924, Document 613;

WHEREAS, in accordance with that certain letter Re: Termination of Revolving Credit Facility dated on or about the date of this Intellectual Property Security Release and sent by the Collateral Agent (the “**Release**”), the obligations secured by the Intellectual Property Collateral have been repaid or otherwise satisfied to the extent set forth in such Release; and

WHEREAS, the Collateral Agent therefore desires to release its security interest in and to the Grantors’ right, title and interest in and to the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and each of the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent does hereby release, without recourse, representation or warranty of any kind, all of the Collateral Agent’s right, title and interest in and to each of the Grantor’s right, title and interest in and to the Intellectual Property Collateral.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks, the Commissioner for Patents and any other applicable government officer record this Intellectual Property Security Release.



This Intellectual Property Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. SECTION 3. Governing Law. This Intellectual Property Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
