

FOR GOOD AND VALUABLE CONSIDERATION, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral, as defined below, pursuant to the Trademark Security Agreements described below, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Lien Release, Agent hereby terminates, releases and discharges its liens on and security interests in the trademarks listed on Schedule A attached hereto and made a part hereof ("Trademark Collateral"), which liens and security interests were established under and pursuant to that certain Trademark Security Agreement dated April 25, 2018 executed by the Company in favor of Agent and recorded with the United States Patent and Trademark Office on May 16, 2018 at reel: 6380 frame: 0120 and that certain Trademark Security Agreement dated February 1, 2019 executed by Connecture Commercial, LLC in favor of Agent and recorded with the United States and Patent Trademark Office on February 4, 2019 at reel: 6549 frame: 0114, and any right, title or interest of Agent in the liens and security interests in such Trademark Collateral shall hereby cease and become void. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and

to do such other acts as may be reasonably necessary to effect the release of the liens and security interests contemplated hereby.
