Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware (the "DGCL"), Datatel Parent Corp., a Delaware corporation (the "Company"), in connection with the merger of Datatel Investment Holding Corp., a Delaware corporation ("Datatel Investment"), with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent corporations to the Merger (the "Constituent Corporations") are:

SECOND: An Agreement and Plan of Merger, by and between the Company and Datatel Investment, and any other party signatory thereto (the "Merger Agreement"), setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with Section 251 of the DGCL (and by the written consent of their respective stockholders in accordance with Section 228 of the DGCL).

THIRD: The Company shall be the surviving corporation of the Merger (the "Surviving Corporation"). The name of the surviving corporation is "Datatel Parent Corp."


FOURTH: Upon the Effective Time (as defined below), the Certificate of Incorporation of the Company shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: The Merger shall become effective as of 12:16 a.m. Eastern Standard Time on December 31, 2016 (the "Effective Time").

SIXTH: An executed copy of the Merger Agreement is on file at the office of the Surviving Corporation located at 4375 Fair Lakes Court, Fairfax, VA 22033. A copy of the Merger Agreement will be furnished by the Surviving Corporation, upon request and without cost, to any stockholder of either of the Constituent Corporations.
