**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement ("Assignment"), effective as of FEBRUARY 26, 2019 ("Effective Date"), is made by and between EmployBridge, a Georgia Corporation ("Assignor") and EB IP HOLDINGS, LLC, a Delaware Limited Liability Company ("Assignee"), with regard to:

- United States Trademark Reg. No. 5239484 for the mark LEADING EDGE DELIVERY, which issued on July 11, 2017 (the "Mark").

Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Mark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.

This Assignment may be signed in any number of counterparts, including electronic counterparts, with the same effect as if the signature on each counterpart were on the same instrument.
