INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (“**IP Assignment**”), dated as of October 31, 2017 is made by LANXESS CORPORATION, a Delaware corporation (“**Seller**”), in favor of, INTERNATIONAL DIOXIDE, INC., a Delaware corporation (“**Company**”), having an address of 554 Ten Rod Road, North Kingstown, Rhode Island 02852, pursuant to the Stock Purchase Agreement by and among SUPERIOR PLUS US HOLDINGS INC., a Delaware corporation (“**Buyer**”), and Seller, dated as of October 12, 2017 (the “**Stock Purchase Agreement**”).

WHEREAS, under the terms of the Stock Purchase Agreement, Seller has agreed to sell all of the issued and outstanding shares of the Company to Buyer;

WHEREAS, under the terms of the Stock Purchase Agreement, Seller agreed to execute and deliver to the Company this Intellectual Property Assignment Agreement in order to ensure that the Company obtains ownership in those trademarks listed on Exhibit A hereto;

NOW THEREFORE, Seller agrees as follows, with the intent to be legally bound:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers and assigns to the Company, and Company hereby accepts, all of Seller's right, title and interest in and to the following (the “**Assigned IP**”):

(a) the trademark registrations set forth on Exhibit A hereto, and all issuances, extensions and renewals thereof (the “**Trademarks**”), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

(b) all rights of any kind whatsoever of Seller accruing under any of the Trademarks above; and

(c) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, if there may be any, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

(d) Company hereby accepts the foregoing assignment and expressly assumes any and all liability, debts and obligations associated with the Trademarks.

2. Recordation and Further Actions. Seller hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by the Company. Seller shall, and shall ensure that any of the relevant affiliates of Seller, cooperate as requested by the Company in the execution and delivery of any and all other instruments and papers and the taking of any and all additional actions necessary to effectuate the

purposes and intent of the transaction provided for herein and otherwise to consolidate, vest and record in the Company, full and complete ownership of the Trademarks, and in accordance with the terms of the Stock Purchase Agreement. The Company shall be responsible for making such recordations and filings.

3. This Assignment shall inure to the benefit of the Company and its successors and assigns and shall be binding upon the Seller and its successors and assigns;

4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.


5. This IP Assignment shall be deemed to be made and in all respects shall be interpreted, construed and governed by and in accordance with the Laws of the State of Delaware without regard to the conflicts of laws principles thereof.

6. If any provision of this IP Assignment (or any portion thereof) or the application of any such provision (or any portion thereof) to any person or circumstance shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision hereof (or the remaining portion thereof) or the application of such provision to any other persons or circumstances. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of other Trademarks.


