The Corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

FIRST: That the Board of Directors of Sonus Networks, Inc. has duly adopted resolutions by unanimous written consent setting forth a proposed amendment of the Certificate of Incorporation of the Corporation (the "Amendment"), declaring said Amendment to be advisable and calling for the sole stockholder of the Corporation to consider the proposed name change. The resolution setting forth the proposed Amendment is as follows:

RESOLVED, that the Certificate of Incorporation of this Corporation be amended by changing the Article thereof numbered "I" so that as amended, said Article shall be and read as follows:

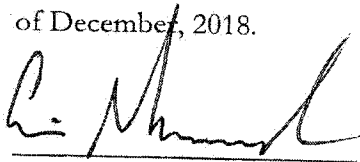
"The name of the corporation (the "Corporation") is **Ribbon Communications Operating Company, Inc.**"
