Trademark Assignment


In consideration of the value received and the mutual covenants of the parties, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

3. Further Acts / Recordal. Assignor further covenants with Assignee to execute when requested such additional assignments, instruments and documents as may reasonably be

necessary to effectuate this Assignment and to enable the Assignee to record the Assignment in the territories concerned, including recordings of assignment of trademark suitable for filing with the United States Patent and Trademark Office and equivalent foreign agencies.


