This Plan of Conversion for the conversion of Oregon Television, Inc., an Oregon corporation, into Oregon Television, LLC, an Oregon limited liability company, is hereby adopted by Oregon Television, Inc. pursuant to ORS 60.474(1)(a).

1. The name of the business entity prior to conversion is Oregon Television, Inc. Oregon Television, Inc. is an Oregon corporation.

2. The name of the business entity after conversion will be Oregon Television, LLC. Oregon Television, LLC will be an Oregon limited liability company.

3. The conversion shall be on the terms and conditions set forth in ORS 60.472 and ORS 63.470. Upon filing of the Articles of Conversion and this Plan of Conversion (which has attached to it as Exhibit A, a copy of the initial Articles of Organization of Oregon Television, LLC), with the Secretary of State of Oregon, Oregon Television, Inc., an Oregon corporation, will be converted into Oregon Television, LLC, an Oregon limited liability company.

4. Oregon Television, Inc. has one shareholder: CCI Television, LLC, a Delaware corporation ("Parent"). Parent owns 712.5 shares of common stock in Oregon Television, Inc. which constitutes 100% of the issued and outstanding capital stock of Oregon Television, Inc. (the "Parent Shares").

5. Upon conversion, all of the Parent Shares will be exchanged for 100% of the membership interests in Oregon Television, LLC. The conversion will result in Parent owning 100% of the issued and outstanding membership interests in Oregon Television, LLC immediately following the conversion.

6. Pursuant to the requirements of ORS 63.047(1), the initial Articles of Organization of Oregon Television, LLC are required to contain the following:

(a) The name of the limited liability company which satisfies the requirements of ORS 63.094 (as required by ORS 63.047(1)(a)): Oregon Television, LLC

(b) The address, including street and number, and mailing address, if different, of the limited liability company's initial registered office and the name of its initial registered agent at that office (as required by ORS 63.047(1)(b)): The address of the limited liability company's initial registered office is 780 Commercial Street SE, Suite 100, Salem, OR 97301, and the name of its initial registered agent at such address is C T Corporation System.

(c) A mailing address to which notices, as required by ORS 63.001 et. seq., may be mailed until an address has been designated by the limited liability company in its annual report (as required by ORS 63.047(1)(c)): 780 Commercial Street SE, Suite 100, Salem, OR 97301.

(d) If the limited liability company will be manager-managed, a statement that the limited liability company will be manager-managed or a statement that the limited liability company is to be managed by a manager or managers (as required by ORS 63.047(1)(d)): The limited liability company will be not be manager managed.
