DECLARATION REGARDING THE TRANSFER OF TITLE
FROM UNITED GUARANTY CORPORATION TO ARCH U.S. MI SERVICES INC.

The undersigned, Theresa M. Cameron, Vice President and Associate General Counsel of Arch U.S. MI Services Inc. declares as follows:

1. I have served as Vice President and Associate General Counsel of Arch U.S. MI Services Inc. ("Assignee") for two years, and am authorized to make this declaration on behalf of Assignee in connection with the transfer of all right, title and interest of the marks "SWIFTCLOSE" (Registration Serial No. 5018082), "MI NOW" (Registration Serial No. 5021267), "CU SWIFTCLOSE" (Registration Serial No. 4611451), and "QMI" (Registration Serial No. 4572126) (collectively, together with all common law rights therein, the "Assigned Marks") from United Guaranty Corporation ("Assignor") to Assignee.

2. As of December 31, 2018, Assignor, a Corporation of North Carolina, 230 North Elm Street, Greensboro, North Carolina 27401, an affiliate of Assignee, was voluntarily dissolved. Effective upon the dissolution of Assignor, Assignee became the successor in interest to all right, title and interest in and to all of the assets then owned by Assignor at the time of Assignor's dissolution, including without limitation the Assigned Marks, together with all of the goodwill associated therewith.

3. Upon dissolution of Assignor, Assignor no longer became available to execute appropriate instruments of transfer of the Assigned Marks to Assignee. Accordingly, I am executing this Declaration on behalf of Assignor and Assignee to update title to the Assigned Marks *nunc pro tunc*.

4. Assignee is now the current owner of the Assigned Marks, together with all of the goodwill associated therewith.


5. This declaration is submitted to the U.S. Patent and Trademark Office to request that the title for the Assigned Marks be updated to reflect that Assignee is the current owner of the Assigned Marks based on the information stated above, and to record the same.
