**PARTIAL TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Partial Termination and Release of Security Interest in Trademarks (“Release”) is made as of February 28, 2019, by **UBS AG, STAMFORD BRANCH**, a Switzerland Aktiengesellschaft (AG) (“Administrative Agent”) in favor of **PRINCIPIUM HEALTH, LLC**, a Delaware limited liability company with an address at 4055 Valley View Lane, Suite 400, Dallas, Texas 75244 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a Trademark Security Agreement dated December 21, 2017 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on May 3, 2018 at the United States Patent and Trademark Office at Reel 6325, Frame 0693.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its right, title and interest in, to and under its Trademark Collateral, including without limitation its Trademarks listed in Schedule A.

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in the Trademarks listed in Schedule A as herein provided, including all rights to sue or otherwise recover for infringements, dilutions or other violations thereof and all Proceeds and profits now and hereafter due and/or payable under or with respect to any and all of the foregoing (collectively, the “Released Trademarks”).

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Released Trademarks, and assigns, transfers and conveys to Grantor the Security Interest.


