RELEASE OF GRANT OF SECURITY INTEREST IN U.S TRADEMARKS

This Release of Grant of Security Interest in U.S Trademarks (this “Release”) is made as of February 28, 2019, by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent for the lenders party to that certain Credit Agreement (as defined in the Security Agreement referred to below) (the “Administrative Agent”), for the benefit of CONNECTWISE, INC., a Delaware corporation, as successor-by-merger with ConnectWise.com, Inc., a Florida corporation (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H:

WHEREAS, the Grantor and the Administrative Agent are parties to that certain (i) Pledge and Security Agreement, dated as of December 1, 2015 (as amended, restated or otherwise modified through the date hereof, the “Security Agreement”), and (ii) each Notice of Grant of Security Interest in U.S Trademarks (each such notice, a “Short Form IP Security Agreement”), pursuant to which the Grantor has granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in and to the trademarks and trademark applications set forth on Schedule I hereto (the “Trademarks”);

WHEREAS, each Short Form IP Security Agreement was recorded in the United States Patent and Trademark Office on (i) December 2, 2015 at Reel 5680 and Frame 0271, (ii) February 5, 2016 at Reel 5724 and Frame 0973, and (iii) February 5, 2016 at Reel 5744 and Frame 0541.

WHEREAS, the Grantor has requested that the Administrative Agent release, and the Administrative Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. The Administrative Agent, on behalf of itself and the Lenders, does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or each Short Form IP Security Agreement to the Trademarks, and any right, title or interest of the Administrative Agent in such Trademarks shall hereby terminate, cease and become void. The Administrative Agent hereby assigns, transfers and conveys any and all right, title or interest of the Administrative Agent in the Trademarks to the Grantor, and all goodwill of the business connected with the use of, and symbolized by such Trademarks.

2. The Administrative Agent further agrees to provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, to execute any other documents) and take any further action that the Grantor may reasonably request to effect the intent and purpose of this Release; provided, that all such

documents are to be prepared by counsel to the Grantor and the cost and expense of such documents and actions shall be borne solely by the Grantor.


