**SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Supplement to Intellectual Property Security Agreement (this “*Supplement*”), dated as of February 26, 2019, is by and between **SILICON VALLEY BANK**, a California corporation (“*Bank*”), and **USER ZOOM, INC.**, a Delaware corporation, and **USERZOOM TECHNOLOGIES, INC.**, a Delaware corporation (each and together, the “*Grantor*”).

**WHEREAS**, Grantor executed and delivered that certain Intellectual Property Security Agreement dated as of December 9, 2016 (as amended of record from time to time hereinafter, the “*IP Agreement*”) in favor of the Bank, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral (as defined in the IP Agreement), which was recorded with the Trademark division of the United States Patent and Trademark Office on December 13, 2016 at Reel 5946, Frame 0805.

**WHEREAS**, the Grantor has developed additional trademark and trademark applications (“*Trademarks*”), and desires to confirm the pledge of, and the grant of a security interest in, such additional Trademarks in favor of Bank.

**WHEREAS**, the Grantor has developed additional patent and patent applications (“*Patents*”), and desires to confirm the pledge of, and the grant of a security interest in, such additional Patents in favor of Bank.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Supplement to Exhibit C. Exhibit C to the IP Agreement is hereby supplemented, but not replaced, by Exhibit C-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
  - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.


