RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of March 13, 2018, is made by NewStar Financial, Inc., as administrative agent (in such capacity, the "Agent") for the Lenders and other Secured Parties (each as defined in the Agreement referred to below), in favor of Credit Infonet, Inc., EZ-Filing, Inc., Online Credit Reporting Corporation, and Best Case, LLC (each, a "Grantor" and, together, the "Grantors").

WHEREAS, the Grantors and the Agent are parties to that certain Guaranty and Security Agreement, dated as of April 26, 2013 (as amended, restated, supplemented and/or modified from time to time, the "Security Agreement") pursuant to which each Grantor executed and delivered in favor of the Agent that certain Trademark Security Agreement, dated as of April 26, 2013 (the "Agreement");

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on April 26, 2013 at Reel 5015/ Frame 0306; capitalized terms used but not defined herein will have the meaning given to them (including by reference) in the Agreement;

WHEREAS, pursuant to the Security Agreement and the Agreement, each Grantor mortgaged, pledged and hypothecated to the Agent for the benefit of the Secured Parties, and granted to Agent for the benefit of the Secured Parties a Lien on and security interest in all of such Grantor's right, title and interest in, to and under (a) all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those Trademarks referred to on Schedule 1 hereto, (b) all renewals and extensions of the foregoing, (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark and (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the "Trademark Collateral"); and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral and execute and deliver this Release to evidence the termination and release thereof for filing with the USPTO.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby (a) fully and finally releases and terminates (i) the Agreement, (ii) its and the Secured Parties' mortgage, pledge and hypothecation of, and Lien on and security interest in, and other rights in, to and under, the Trademark Collateral and (iii) any and all other rights it or the Secured Parties may have under the Agreement, and (b) re-assigns to the Grantors, any right the Agent or the Secured Parties may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby. The Grantors (or its designees) are hereby authorized to file this Release with the USPTO and any other governmental authority.

The delivery of an executed counterpart of a signature page to this Release by email or facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall relate solely to the Agreement.
