DECLARATION OF APPLICANT
REGARDING TRADE NAME

I, Sid J. Trant, the Secretary of The Board of Trustees of The University of Alabama (“Board of Trustees”), do declare as follows in the paragraphs below. All statements made herein of my own knowledge are true, and all statements made on information and belief are believed to be true.

I am properly authorized to make the statements herein and to execute this document on behalf of the Board of Trustees.

The Board of Trustees is a public educational instrumentality of the State of Alabama established under the authority of the Constitution of the State of Alabama (Ala. Const. Art. XIV, Sec. 264), and recognized as a body corporate in the Code of Alabama, 1975, Title 16, Chapter 47, Sec. 1), with its true and correct formal name as “The Board of Trustees of The University of Alabama”. The Board of Trustees is a valid and existing corporate entity under such name.

In connection with its constitutional and statutorily authorized business, the Board of Trustees has established multiple campuses of the state university, in various cities, and in connection therewith has adopted and uses various trade names, d/b/a’s, and other monikers, all used with an intent and effect of referring singularly to the Board of Trustees. Although not an exhaustive list, among such trade names are the following names:

- The University of Alabama
- The University of Alabama at Birmingham
- The Board of Trustees of The University of Alabama for The University of Alabama at Birmingham
- The Board of Trustees of The University of Alabama for and on behalf of The University of Alabama at Birmingham
- The Board of Trustees of The University of Alabama a public corporation for The University of Alabama at Birmingham
- The University of Alabama in Huntsville

Additionally, as a matter of form and convenience, the Board of Trustees has from time to time used its formal corporate name and these various trade name forms without including the “The” at the beginning as shown in the list above.

The usage of any and all of these names and forms by the Board of Trustees refers to, and at all times has referred to, the Board of Trustees in its full and legal capacity. All such uses would be understood by all in the trade to refer to the Board of Trustees and no other.

The Board of Trustees from time to time has executed documents and conducted business in the various names mentioned above or in forms substantially similar to the names mentioned above, and in each case was and is effectively and intentionally referring to itself and no other.

For convenience and consistency of management, the Board of Trustees desires to update the records relating to its ownership of trademarks, to reflect its full formal corporate name, “The Board of Trustees of The University of Alabama”. The updating of records to reflect this full formal corporate name does not evidence or imply any change of control, change of entity, assignment, or conveyance.

The Board of Trustees intends to continue to use certain of the trade names set forth above, and possibly others, to conduct business and to designate itself. The change of name for purposes of trademark ownership records mentioned herein does not operate as a disavowal of any previously-used trade name of the Board of Trustees, or of any action or interest that was previously taken or held (or that may be taken or held in the future) by the Board of Trustees in any such name.

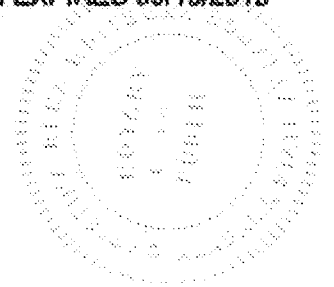
