## TERMINATION OF TRADEMARK SECURITY INTEREST

This **TERMINATION OF TRADEMARK SECURITY INTEREST**, effective as of February 28<sup>th</sup>, 2019, is made by **JPMorgan Chase Bank, N.A.**, as administrative agent (the "Secured Party"), in favor of **InComm Agent Solutions, Inc., (f/k/a QPay, Inc.)** a Florida corporation ("Debtor"), with an address of 250 Williams Street, Suite M-100, Atlanta, Georgia 30303.
