TERMINATION OF TRADEMARK SECURITY INTEREST

This **TERMINATION OF TRADEMARK SECURITY INTEREST**, effective as of February 28th, 2019, is made by **JPMorgan Chase Bank, N.A.**, as administrative agent (the "Secured Party"), in favor of **E2INTERACTIVE, INC.**, a Georgia corporation ("Debtor"), with an address of 250 Williams Street, Suite M-100, Atlanta, Georgia 30303.

WHEREAS, pursuant to that certain Third Amended and Restated Security Agreement dated as of January 9, 2015 (as may be amended and in effect from time to time, the "Security Agreement") and the Trademark Security Agreement dated January 9, 2015 (the "Trademark Security Agreement"), Debtor granted to Secured Party a continuing security interest in all of Debtor's right, title and interest in, to and under all Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in Schedule A.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 21, 2015 at Reel 5444 and Frame 0646.

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates and releases all liens and security interests in the Trademark Collateral including the trademarks listed in Schedule A.
