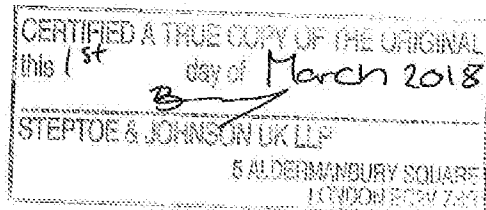

THIS DEED is dated 15 December 2017

PARTIES

- (1) **SPRING HOLDINGS S.Á R.L.**, a Luxembourg private limited liability company (société à responsabilité limitée) having its registered office at 6, rue Dicks, L-1417 Luxembourg, Grand Duchy of Luxembourg and registered with the Luxembourg Register of Commerce and Companies under number B 181225 (the "Assignor")
- (2) **HENRY COTTON'S BRAND MANAGEMENT COMPANY LIMITED**, a company incorporated in Ireland under registration number 617071 and having its registered office at 10 Earlsfort Terrace, Dublin 2, DO2 T380, Ireland (the "Assignee")

each a "Party" and together the "Parties".

BACKGROUND

- (A) The Assignor has agreed to sell and the Assignee has agreed to buy the property, rights, licenses and assets relating to the brand known as Henry Cotton's subject to and on the terms and conditions of an Asset Purchase Agreement dated on or about the date of this Deed.
- (B) For the above transfer to be effective the Assignor wishes to assign all Intellectual Property Rights which it holds in the Trade Marks and the Domain Names to the Assignee subject to and on the terms and conditions of this Deed.

IT IS AGREED:

1. DEFINITIONS

The definitions and rules of interpretation in this clause apply in this Deed.

Domain Names: the domain names, brief particulars of which are set out in Part 2 of the attached Schedule.

Intellectual Property Rights: all intellectual property rights including without limitation trade marks (including service marks, trade names and business names), design rights, copyright and related rights, internet designations (including domain names), moral rights, (whether or not any of these is registered and including any application for registration of any such rights), confidential information and trade secrets for the full term of such rights and including any extension to or renewal of the terms of such rights and all rights or forms of protection of a similar nature or having similar effect to any of these which may exist anywhere in the world;

Trade Marks: the trade mark registrations, brief particulars of which are set out in Part 1 of the attached Schedule.

2. ASSIGNMENT

In consideration of the payment of the sum of EUR10.00 by the Assignee to the Assignor (receipt and sufficiency of which is hereby acknowledged), the Assignor hereby assigns, transfers and conveys to the Assignee absolutely free from encumbrances, charges, liens or any other adverse right or interest, all of its right, title and interest, including all Intellectual Property Rights owned by the Assignor, in and to the Trade Marks and the Domain Names, (the "Assigned Rights") together with all statutory and common law rights and goodwill therein, wherever in the world, together with all the rights of action, powers and benefits belonging to the same, including the right to bring, make, oppose, defend, appeal and obtain relief for (and to retain any damages recovered) in respect of any proceedings, claims or

actions for infringement, or any other cause of action arising from ownership, of any of the Assigned Rights whether occurring before, on or after the date of this Deed.

3. WARRANTIES

- 3.1 Each Party warrants that it has full capacity and authority to enter into and to perform this Deed.
- 3.2 The Assignor warrants to the Assignee that it is the legal and beneficial owner of the Assigned Rights.
- 3.3 Except as set out in this Deed, the Assigned Rights are assigned "as is" and all conditions, warranties and representations, expressed or implied by statute, common or civil law or otherwise, are excluded to the maximum extent permitted by law.

4. POWER OF ATTORNEY

The Assignor irrevocably (by way of security to secure the proprietary interest of the Assignee in the Assigned Rights) and unconditionally appoints the Assignee as its attorney to do and perform any acts and things which the Assignee in its absolute discretion considers necessary or desirable in connection with the registration of the Assigned Rights with the applicable official intellectual property registries from Completion until the date on which the Assignee or its nominee is entered in such registries as the registered holder of the Assigned Rights.

5. FURTHER ASSURANCE

The Assignor shall, at no additional charge, as required or deemed appropriate by the Assignee and at the cost and expense of the Assignee, now or at any time in the future, promptly execute all such documents and do all such other acts or things as may be necessary or desirable to give full effect to this Deed and secure to the Assignee the full benefit of the Assigned Rights.

6. ENTIRE AGREEMENT

This Deed represents the entire agreement between the parties with respect to its subject matter and supersedes, extinguishes and replaces all prior agreements, arrangements, letters and discussions between the Parties in relation to such matters. Each Party confirms that it has not relied upon any representations not recorded in this document inducing it to enter into this Deed.

7. VARIATION

No variation of these terms and conditions will be valid unless confirmed in writing by authorised signatories of each of the parties on or after the date of this Deed.

8. COUNTERPARTS

- 8.1 This Deed may be executed in any number of counterparts, and by the Parties on separate counterparts, but shall not be effective until each Party has executed at least one counterpart.
- 8.2 Each counterpart shall constitute an original of this Deed, but all the counterparts shall together constitute but one and the same instrument.

9. GOVERNING LAW AND JURISDICTION

9.1 This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

9.2 Any dispute arising out of or in connection with this Deed shall be referred and finally resolved by arbitration under the London Court of International Arbitration Rules which are deemed to be incorporated by reference to this clause 9.2 the number of arbitrators shall be one. The seat or legal place of arbitration shall be London.
