## TRADEMARK ASSIGNMENT CONFIRMATION

This Trademark Assignment Confirmation is made and entered into effective August 16, 2018, by and between Baby's Journey, Inc., a Rhode Island corporation (hereinafter "Assignor"), and Delta Enterprise Corp., a New York corporation having a mailing address of 114 West 26th Street, New York, New York 10001 (hereinafter "Assignee").

WHEREAS, Assignor as of the effective date is the owner of the trademarks set forth in Exhibit A (hereinafter "the Marks"); and

WHEREAS, Assignor is represented by Michael B. Forte, Jr. in his capacity only as the Rhode Island Superior Court's appointed receiver pursuant to a receivership action before the Providence County Superior Court in respect of Baby's Journey, Inc. (C.A. No. PC-2017-4790), and not as an individual; and

WHEREAS, Assignor and Assignee entered into an Intellectual Property Assignment effective August 16, 2018, in which Assignor assigned to Assignee, and Assignee accepted, among other things (a) all of Assignor's right, title and interest in, and good will associated with, Assignor's intellectual property, including trademarks, trademark applications, service marks and trade names, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement or dilution thereof, and (b) any and all rights to currently accruing and future royalties, profits, compensation, license fees, or other payments or remuneration of any kind relating thereto; and

WHEREAS, Assignor and Assignee want to confirm the assignment of the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee its entire right, title, and interest in and to the Marks and registrations for the Marks, together with the goodwill of the business symbolized by the Marks and registrations thereof, and all other rights which Assignor has enjoyed thereunder, including any and all rights of recovery based on past infringement of, and royalties, profits, compensation, license fees and other payment or remuneration of any kind relating to, said Marks and registrations, the same to be held and enjoyed by Assignee, its successors and assigns.


