**TRADEMARK RELEASE AND REASSIGNMENT**

This Trademark Release and Reassignment is entered into as of March 10, 2019, by Wells Fargo Bank, National Association, a national banking association, in its capacity as agent for the Secured Parties (the "Agent").

The Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on December 20, 2016, at Reel 5940, Frame 0550.


The Grantor has requested that the Agent release its security interest in the Trademarks.

Subject to other security interests, if any, granted by the Grantor to other financial institutions, the Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, all of the Agent's right, title and interest in and to the Trademarks, including without limitation the Trademarks set forth on Schedule 1 hereto.
