**TRADEMARK RELEASE AND REASSIGNMENT**

This Trademark Release and Reassignment is entered into as of March 6, 2019, by Wells Fargo Bank, National Association, a national banking association, in its capacity as agent for the Secured Parties (the "Agent").

Subject to other security interests, if any, granted by the Grantor to other financial institutions, the Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, all of the Agent's right, title and interest in and to the Trademarks, including without limitation the Trademarks set forth on Schedule 1 hereto.
