TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of October 1, 2018, by Lux Products Corporation, a Delaware corporation ("Assignor"), and Johnson Controls, Inc., a Wisconsin corporation ("Assignee"), pursuant to the Asset Purchase Agreement dated as of September 10, 2018, by and among Assignor, Assignee, and Edwin McAuley Electronics Inc., a private limited company organized in the British Virgin Islands (the "Purchase Agreement").

The Purchase Agreement provides, among other things, for the sale and transfer by Assignor to Assignee of certain assets including the trademarks listed on the attached Exhibit A (the "Trademarks") along with any and all goodwill appurtenant thereto. This Assignment is made and delivered in accordance with the Purchase Agreement in order to provide a document suitable for public recordation to evidence the transfer of interest in the Trademarks as provided in the Purchase Agreement.

NOW, THEREFORE, pursuant to the Purchase Agreement, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and delivers to Assignee, and Assignee's successors and assigns, all of Assignor's rights, title and interest in, to and under the Trademarks, together with their common law rights, goodwill and the business associated with the Trademarks, and registrations and pending registration applications thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements and damages), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made. With respect to any intent-to-use trademark applications identified on Exhibit A hereto, the transfer of such applications accompanies, pursuant to the Purchase Agreement, the transfer of Assignor's business, or that portion of the business to which the Trademark pertains, and that business is ongoing and existing.

Assignor agrees to execute and deliver to Assignee, promptly upon request, any additional documents that are reasonably necessary to record or perfect Assignee's interest in, ownership of or title to the Trademarks, to clear any encumbrances on the Trademarks, or otherwise give full effect to the purposes of this Assignment.

Assignor authorizes and requests any official in the country listed on the attached Exhibit A, whose duty it is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of any and all of Assignor's right, title and interest in and to the Trademarks.

Nothing contained in this Assignment will in any way supersede, modify, amend, waive or otherwise affect any of the provisions set forth in the Purchase Agreement, including without limitation any of the representations, warranties, covenants and agreements set forth therein, this Assignment being intended only to effect the transfer by Assignor to Assignee of the Trademarks. In the event of any conflict or inconsistency between the Purchase Agreement and this Assignment, the Purchase Agreement will control.

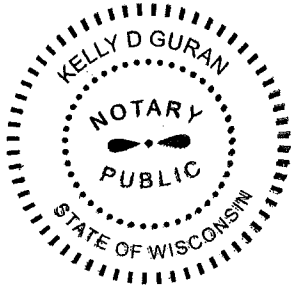


