**RELEASE OF RECORDED SECURITY INTEREST IN CERTAIN TRADEMARKS  
(EXCLUDED ASSETS)**

This **RELEASE OF RECORDED SECURITY INTEREST IN CERTAIN TRADEMARKS (EXCLUDED ASSETS)** (this "Release") is dated as of February 20, 2019 by Cortland Capital Market Services LLC, as collateral agent (in such capacity, and together with its successors and permitted assigns, the "Second Lien Collateral Agent"), in favor of Pure Fishing, Inc., Penn Fishing Tackle Mfg. Co., and Shakespeare All Star Acquisition LLC (collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement (as defined below).

**WHEREAS**, Grantors and Collateral Agent are parties that certain Intellectual Property Security Agreement dated December 21, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), pursuant to which Grantors granted to the Second Lien Collateral Agent a security interest in all of the Grantors' right, title and interest in and to certain trademark Collateral (as defined in the IP Security Agreement), which excluded any Excluded Asset (which included any intent-to-use application for the registration of a trademark or service mark unless and until a statement of use or amendment to allege use is filed in the PTO with respect thereto, but only to the extent, if any, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration issuing form such intent-to-use application under applicable federal law);

**WHEREAS**, the intent-to-use trademark applications set forth on Schedule A attached hereto (the "Released Trademarks") are considered Excluded Assets and thus should not have been recorded against by the IP Security Agreement submitted for recordation with the United States Patent and Trademark Office on December 27, 2018 with ETAS ID TM503643; and


**WHEREAS**, in order to clarify the public record, Second Lien Collateral Agent hereby wishes to record this Release of the Released Trademarks together with a release of (i) all Proceeds and products of the Released Trademarks, (ii) the goodwill of the businesses with which the Released Trademarks are associated, and (iii) all causes of action arising prior to or after the date of the IP Security Agreement for infringement of any of the Released Trademarks or unfair competition regarding the same (together with the Released Trademarks, the "Released Trademark Rights").

**NOW, THEREFORE**, for and in consideration of the foregoing, the Second Lien Collateral Agent hereby, without any representation and warranty and without any recourse to the Second Lien Collateral Agent, (a) terminates and releases the security interest in the Released Trademark Rights, including the Released Trademarks, and (b) re-assigns, re-transfers and re-conveys to Grantors any and all right, title or interest the Second Lien Collateral Agent may have in, to or under the Released Trademark Rights; provided that such release shall not affect the obligations of Grantors to grant to the Second Lien Collateral Agent and the Second Lien Collateral Agent's existing rights in a security interest in any of the Released Trademarks if they no longer qualify as Excluded Assets.
