ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS

This Assignment of Intellectual Property Security Agreements (this “Agreement”) is dated effective February 8, 2019 by and among RLJ Entertainment Holdings LLC (formerly Digital Entertainment Holdings LLC) (“Resigning Agent”) and AMC Networks Ventures LLC (“Successor Agent”).

WHEREAS, the Resigning Agent is Administrative Agent and Collateral Agent under that certain Amended and Restated Credit and Guaranty Agreement dated as of October 31, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “Credit Agreement”) by and among RLJ Entertainment, Inc. (“Parent Borrower”), certain Subsidiaries of Parent Borrower, as Guarantor Subsidiaries (the “Guarantor Subsidiaries”), the Lenders party thereto from time to time, and the Resigning Agent, as Administrative Agent and Collateral Agent. Capitalized terms used herein and not otherwise defined in this Agreement have the meanings given to such terms in the Credit Agreement;

WHEREAS, pursuant to an Assignment and Assumption Agreement dated as of December 20, 2018 (the “Assignment and Assumption Agreement”), RLJ Entertainment Holdings LLC (formerly Digital Entertainment Holdings LLC) sold and assigned to AMC Networks Ventures LLC all of its rights and obligations under the Credit Agreement, as a result of which AMC Networks Ventures LLC became the sole Lender thereunder; and

WHEREAS, pursuant to Section 9.8 of the Credit Agreement, the Resigning Agent desires to resign as Administrative Agent and as Collateral Agent under the Credit Agreement, and AMC Networks Ventures LLC, as Requisite Lender, and following consultation with the Parent Borrower, desires to appoint a successor Administrative Agent and Collateral Agent thereunder;

NOW THEREFORE, in consideration of the mutual agreements set forth herein, the parties hereto agree as follows:



1. Assignment. Effective as of the date hereof, the Resigning Agent hereby irrevocably sells and assigns to the Successor Agent, and the Successor Agent hereby irrevocably purchases and assumes from the Resigning Agent, subject to and in accordance with the Standard Terms and Conditions set forth in the Assignment and Assumption Agreement and the Credit Agreement, all of its right, title, and interest in the Trademark Security Agreement, recorded at reel/frame 5902/0342 in the United States Patent and Trademark Office on October 17, 2016 and attached as Exhibit A, and the Copyright Security Agreement, recorded at document number V9940D885 in the United States Copyright Office October 18, 2016 and attached as Exhibit B.
2. Counterparts. This Agreement may be executed in any number of counterparts, which together shall constitute one instrument. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart of this Agreement.

3. Severability. If any provision of this Agreement is or becomes invalid, illegal or unenforceable in any respect under any law, the validity and enforceability of the remaining provisions shall not be affected or impaired in any way.
4. Governing Law. This Agreement shall be governed by, and construed in accordance with, the internal laws of the State of New York without regard to conflict of laws principles thereof. The provisions of Sections 10.14 and 10.15 of the Credit Agreement are hereby incorporated into this Agreement by reference.
5. Reference to and Effect on the Credit Documents.
 - (a) Except as specifically modified by this Agreement, the Credit Documents shall remain in full force and effect and are hereby ratified and confirmed in all respects and shall remain in full force and effect in accordance with their respective terms.
 - (b) Upon the execution and delivery of this Agreement by the Resigning Agent and the Successor Agent, this Agreement shall be considered to be and constitutes a Credit Document for the purposes of the Credit Agreement and each other Credit Document.



Trademark Security Agreement

TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT**, dated as of October 14, 2016 (as it may be amended, restated, supplemented or otherwise modified from time to time, this “**Agreement**”), is made by the entities identified as grantors on the signature pages hereto (collectively, the “**Grantors**”) in favor of DIGITAL ENTERTAINMENT HOLDINGS LLC, as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “**Collateral Agent**”).

WHEREAS, the Grantors are party to a Pledge and Security Agreement dated as of October 14, 2016 (the “**Pledge and Security Agreement**”) between each of the Grantors and the other grantors party thereto and the Collateral Agent pursuant to which the Grantors granted a security interest to the Collateral Agent in the Trademark Collateral (as defined below) and are required to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors hereby agree with the Collateral Agent as follows:

SECTION 1. Defined Terms

Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral

SECTION 2.1 Grant of Security. Each Grantor hereby mortgages, pledges, hypothecates and grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under the following, in each case whether now owned or existing or hereafter acquired, developed, created or arising and wherever located (collectively, the “**Trademark Collateral**”):

all United States, and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, whether or not registered, and with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, the registrations and applications listed or required to be listed in Schedule A attached hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (iv) the right to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill, (v) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.

SECTION 2.2 Certain Limited Exclusions. Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2.1 hereof attach to any “intent-to-use” application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a “Statement of Use” pursuant to Section 1(d) of the Lanham Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which, the

grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law.

SECTION 3. Security Agreement

The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Collateral Agent for the Secured Parties pursuant to the Pledge and Security Agreement, and the Grantors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall control.

SECTION 4. Governing Law

THE VALIDITY OF THIS AGREEMENT, THE CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT HEREOF, THE RIGHTS OF THE PARTIES HERETO WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO, AND ANY CLAIMS, CONTROVERSIES OR DISPUTES ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).

SECTION 5. Grantor Remains Liable

Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Trademarks subject to a security interest hereunder.


SECTION 6. Counterparts

This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.





any and all agreements, licenses and covenants providing for the granting of any exclusive right to such Grantor in or to any registered Copyright including, without limitation, each agreement required to be listed in Schedule A attached hereto, and the right to sue or otherwise recover for past, present and future infringement or other violation or impairment thereof, including the right to receive all Proceeds therefrom,

including without limitation license fees, royalties, income, payments, claims, damages and proceeds of suit, now or hereafter due and/or payable with respect thereto.

Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Copyrights subject to a security interest hereunder.


