Article One of the Amended and Restated Certificate of Incorporation of the Corporation shall be deleted in its entirety and replaced in full with the following Article One:

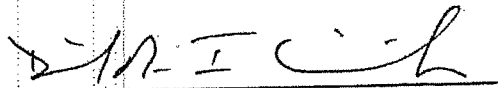
“The name of the Corporation is Unison Marketplace, Inc.”
