**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of March 8, 2019, by Hayfin Services LLP, as administrative agent (the “Administrative Agent”) in favor of Fourth Dimension Spine, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantor, among others, entered into a certain Trademark Security Agreement, dated August 26, 2016 (the “2016 Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on August 26, 2016 at the United States Patent and Trademark Office (the “USPTO”) at Reel 5864, Frame 0618;

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its Trademark Collateral, including without limitation the trademarks listed in Schedule A attached hereto, and all of the goodwill associated with such Trademark Collateral;

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided;


WHEREAS, the Grantor has requested that the Administrative Agent execute and deliver this Trademark Release to evidence the release of the Administrative Agent’s security interest in the Trademark Collateral for filing and recordation with the USPTO;

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders and other holders of the Security Interest, hereby releases, terminates and discharges any and all of its security interest in, to, or under the Trademark Collateral, including the goodwill associated with such Trademark Collateral, and assigns, transfers and conveys to the Grantor any and all such right, title and interest that the Administrative Agent may have in such intellectual property, including the Security Interest. Any right, title, or interest of the Administrative Agent in the Trademark Collateral shall hereby cease and become void.
