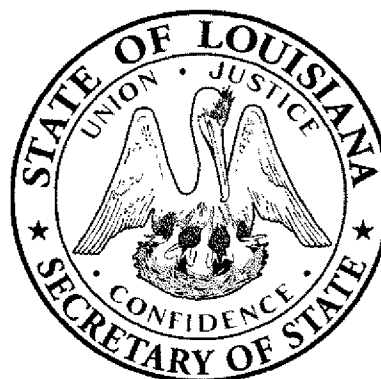

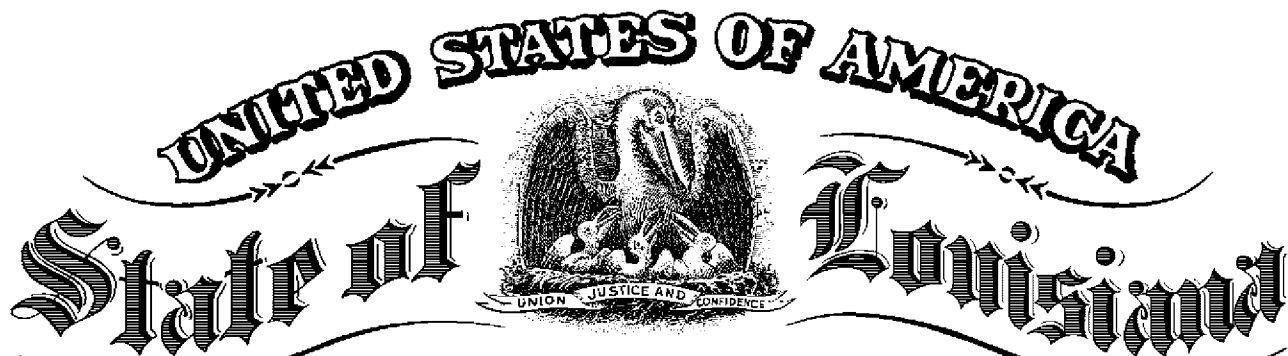

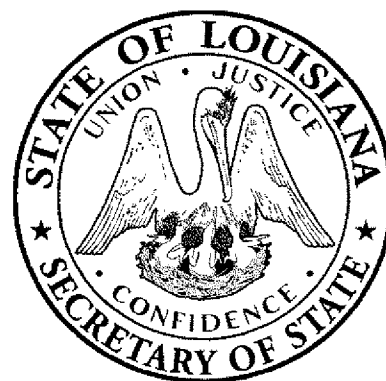

The name of the corporation is Sassy Baby, Inc."


3. The Amendment was duly adopted on October 25, 2018.
