

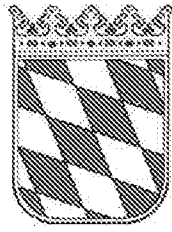

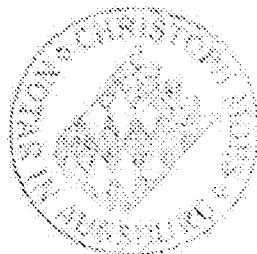
- that **MAN B & W Diesel Aktiengesellschaft** with its seat in Augsburg (Germany) was registered under the aforesaid No. HRB 52.


