## TRADEMARKS ASSIGNMENT

This Assignment is made and entered into as of January 10, 2019, to assign trademark rights to Quest Products, LLC, a Delaware limited liability Company.

1. Effective January 8, 2019, by action of its President, Jeffrey T Haley, OraHealth Corporation converted from a corporation to a limited liability company (LLC) under the laws of the State of Washington and is identified thereafter as OraHealth, LLC.

2. Effective January 9, 2019, OraHealth, LLC merged into common ownership with Quest Products, LLC, 8201 104th Street, Suite 200, Pleasant Prairie, WI 53158 and Steven R. Brown became the President of OraHealth LLC.

3. Also effective January 9, 2019, by the action of its President, Steven R. Brown, OraHealth LLC granted to MB Financial Bank, N.A. a security interest in, and a lien upon, all of OraHealth LLC's right, title and interest in and to (i) the trademarks, trademark registrations, trademark applications, trademark licenses, and any and all goodwill associated therewith (the "Trademarks") set forth on Schedule A attached hereto, together with (ii) all Proceeds (as such term is defined in the Guaranty and Collateral Agreement) of the Trademarks, and (iii) all causes of action, past, present and future, for infringement, or dilution of any of the Trademarks.

4. OraHealth, LLC hereby assigns to Quest Products, LLC, subject to the security interest of MB Financial Bank, N.A. referenced above, all rights it may have in all countries of the world in the Trademarks as set forth on Schedule A attached hereto, as well as:

(a) all registered or unregistered trademarks, service marks, trade dress, trade styles, logos, trade names, brand names, product names, slogans, corporate names and other identifiers of source, including all goodwill associated therewith, and all common law rights, applications, registrations and renewals in connection therewith; along with

(b) all rights in internet domain names, url's, e-mail addresses, social media accounts, phone numbers and registrations in respect thereof,


(c) in all countries of the world,

(d) including all such rights held in its former corporate name, OraHealth Corporation.

D. OraHealth, LLC and its former President, Jeffrey T Haley, agree to provide all reasonable assistance and cooperation requested by Quest Products, LLC in connection with any effort to register, establish, perfect or defend its above specified rights, including without limitation (a) executing assignments, declarations, releases and other documentation establishing the rights; (b) appearing as a party in litigation if Quest Products, LLC determines that such participation will assist in the litigation, in

which case Quest Products, LLC shall reimburse all the reasonable costs (including but not limited to travel cost, lodging cost, taxes, insurance, counsel fees and litigation expenses and all other costs and benefit) incurred by OraHealth, LLC or its former President, Jeffrey T Haley, participating in such litigation.


