**AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

This **AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**, dated as of December 24, 2018 (as it may hereafter be amended, restated, supplemented or otherwise modified from time to time, this “**Agreement**”), is made by and between Playboy Enterprises International, Inc. (“**PEII**”), Playboy Enterprises, Inc. (“**PEI**”), Products Licensing LLC (the “**Original Borrower**”), and China Products Licensing, LLC (“**CPLLLC**”) (PEII, PEI, PLLLC, and CPLLLC, collectively, the “**Grantors**”) and DBD Credit Funding LLC, as administrative agent (in such capacity, together with its successors and permitted assigns, the “**Administrative Agent**”).

**WHEREAS**, pursuant to the Credit Agreement, dated June 24, 2014 (as the same has been amended, restated, supplemented, and/or modified, including the Seventh Amendment dated as of December 24, 2018 (the “**Seventh Amendment**”), and as it may hereafter be further amended, restated, supplemented and/or modified, the “**Credit Agreement**”), initially entered into by the Original Borrower, the other loan parties party thereto, the lenders party thereto (“**Lenders**”) and the Administrative Agent, the Lenders have severally agreed to and provided extensions of credit upon the terms and subject to the conditions set forth therein; and in connection therewith, PEII has agreed, pursuant to the Guaranty and Security Agreement, dated June 24, 2014, in favor of the Administrative Agent (an such agreement may have been amended, restated, supplemented, or otherwise modified, the “**Original Guaranty and Security Agreement**”), to guarantee the Obligations (as defined in the Credit Agreement) of the Original Borrower;

**WHEREAS**, pursuant to the Seventh Amendment, PEI and PEII became additional borrowers and received additional advances of the Loan made pursuant to the Credit Agreement (and are hereinafter sometimes, together with the Original Borrower, collectively referred to as the “**Borrowers**”), and CPLLC agreed to guaranty the Obligations of the Borrowers under the Credit Agreement and to provide collateral security to Administrative Agent for the benefit of the Lenders covering all of the Obligations;

**WHEREAS**, pursuant to the Original Guaranty and Security Agreement, PEII has executed, delivered, and filed the Trademark Security Agreement, dated June 24, 2014 (“**Original Trademark Security Agreement**”), which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on June 30, 2014, at Reel 5312/Frame 0245;

**WHEREAS**, pursuant to the Original Guaranty and Security Agreement, the Original Borrower executed, and filed the Licensed Trademark Security Agreement (Exclusively Licensed Trademarks), dated June 24, 2013 (“**Licensed Trademark Security Agreement**”), which was recorded with the USPTO on June 30, 2014, at Reel 5312/Frame 0315;

**WHEREAS**, pursuant to the Seventh Amendment, all of the Grantors entered into that certain Second Amended and Restated Guaranty and Security Agreement dated as of December 24, 2018 in favor of the Administrative Agent (and such agreement, as it may be hereafter amended, restated, supplemented or otherwise modified from time to time, the “**Second Amended and Restated Guaranty and Security Agreement**”), to guarantee the Secured Debt and the other Obligations (as defined in the Credit Agreement, and collectively, with the Secured Debt, the “**Secured Obligations**”) of the Borrowers, and granted to Administrative Agent, for the benefit of the Lenders (hereinafter, the “**Secured Parties**”) a first priority security interest in all the Collateral (as defined in the Guaranty and Security Agreement) to secure all of the Obligations; and

**WHEREAS**, pursuant to the Second Amended and Restated Guaranty and Security Agreement, the Grantors are required to execute and deliver this Agreement to memorialize the lien granted on all rights in the Trademarks listed on Schedule I attached hereto (the “**Trademarks**”).

**NOW, THEREFORE**, in consideration of the premises and as consideration to the Secured Parties for making the Loans, and to agree to the various other commitments and obligations set forth in the Credit Agreement, the Grantors hereby agree with Administrative Agent as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Second Amended and Restated Guaranty and Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each of the Grantors, as collateral Security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantors, hereby mortgages, pledges, and hypothecates to Administrative Agent for the benefit of the Secured Parties, and grants to Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest in, all of their rights and interest in, to and under the following Collateral:

(a) all of such Grantor's Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark referred to on Schedule I hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present, and future infringement, misappropriation, dilution, violation or other impairment thereof;

provided, however, that none of the foregoing Trademark Collateral shall include any Excluded Assets.

Section 3. Form Supplement. From time to time, Grantors, at the request of Administrative Agent, shall execute a Supplement to Schedule I (in the form attached hereto as Exhibit A) to reflect additions to, deletions from, or other modifications of, Schedule I.

Section 4. Second Amended and Restated Guaranty and Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to Administrative Agent pursuant to the Second Amended and Restated Guaranty and Security Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Second Amended and Restated Guaranty and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 5. Grantors Remain Liable. The Grantors hereby agree that, anything herein to the contrary notwithstanding, the Grantors shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with their Trademarks and IP Licenses subject to the security interest hereunder.

Section 6. Termination. Upon the occurrence of the Termination Date (as defined in the Credit Agreement) or satisfaction of the conditions set forth in Section 10.01(b)(ii) of the Credit Agreement, the Administrative Agent, at the request and the expense of the Grantors, shall execute, acknowledge, and deliver to the Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in all (in the case of the Termination Date) or the applicable portion

of (in the case of a release pursuant to satisfaction of the conditions set forth in Section 10.01(b)(ii) of the Credit Agreement), the Trademark Collateral under this Agreement.

Section 7. Counterparts. This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of this Agreement by facsimile or electronic transmission shall be effective as delivery of a manually-executed counterpart of this Agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.


