RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, effective March 11, 2019, is made by Western Alliance Bank, successor in interest to Bridge Bank, National Association, 55 Almaden Blvd., Suite 100, San Jose, California, 95113, pursuant to the Loan and Security Agreement dated September 19, 2014 between Bridge Bank on the one hand and Curse Inc. and Curse TV, LLC on the other (together, "Grantors"). As used herein, "Trademark Collateral" means US Trademark Registration No. 4120321 for CURSE.

WHEREAS, Grantors granted a security interest in the Trademark Collateral to Bridge Bank pursuant to the Intellectual Property Security Agreement dated September 19, 2014 which is recorded at the United States Patent and Trademark Office ("USPTO") at REEL 005367/FRAME 0359 (the "Security Interest");

WHEREAS, Western Alliance Bank terminated and released the Security Interest as of July 11, 2016; and


WHEREAS, Western Alliance Bank and Grantors wish to record said termination and release with the USPTO.
