### THIRD SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Third Supplement to Intellectual Property Security Agreement (this "Supplement") is made as of the 18th day of March, 2019 by ZOCDOC, INC., a Delaware corporation (the "Grantor") in favor of SILICON VALLEY BANK (the "Grantee").

WHEREAS, the Grantor executed and delivered to Grantee an Intellectual Property Security Agreement dated March 26, 2015 which was (i) recorded with the Trademark division of the U.S. Patent and Trademark Office on March 27, 2015 at Reel 5486, Frame 0534, as corrected by that certain Corrective Assignment recorded with the Trademark division of the U.S. Patent and Trademark Office on April 13, 2015 at Reel 5496, Frame 0263, as amended by that certain First Supplement to Intellectual Property Security Agreement dated June 30, 2016 and recorded with the Trademark division of the U.S. Patent and Trademark Office on July 6, 2016 at Reel 5829, Frame 0474 and, as further amended by that certain Second Supplement to Intellectual Property Security Agreement dated March 27, 2017 and (ii) recorded with the Patent division of the U.S. Patent and Trademark Office on April 13, 2015 at Reel 035412, Frame 0001, as amended by that certain First Supplement to Intellectual Property Security Agreement dated June 30, 2016 and, as further amended by that certain Second Supplement to Intellectual Property Security Agreement dated March 27, 2017 and recorded with the Patent division of the U.S. Patent and Trademark Office on March 28, 2017 at Reel 042107, Frame 0538 (as amended from time to time hereinafter, the "Grant"), pursuant to which the Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral (as defined therein); and

WHEREAS, the Grantor has developed additional Intellectual Property Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property Collateral in favor of the Grantee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Exhibits.
  - a. Exhibit B to the Grant is hereby supplemented, but not replaced, by Exhibit B-1 annexed hereto.
  - b. Exhibit C to the Grant is hereby supplemented, but not replaced, by Exhibit C-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.

- b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
