SHORT FORM TRADEMARK ASSIGNMENT

This trademark assignment (the "Assignment") is by and between Twentieth Century Fox Film Corporation ("Fox") located at 10201 West Pico Blvd, Los Angeles, CA 90064 and Square Enix Limited ("SEL") a limited liability company incorporated in England and Wales, United Kingdom, previously incorporated and trading as Eidos Interactive Ltd ("EIDOS"), located at 240 Blackfriars Road, London, SE1 8NW (each a Party and collectively the "Parties").

Whereas, SEL is the proprietor of various HITMAN trademarks throughout the world, in relation to *inter alia* computer games and related entertainment services, including HITMAN No. 2724811 in Class 9 and HITMAN GO No. 4722213 in classes 9 and 41 in the United States Patent and Trademark Office ("USPTO");

Whereas, Fox has filed application for the mark "HITMAN" in class 41 identified as serial number 87854073 ("Fox Application ") which application is in connection with a television series being developed by Fox pursuant to a license agreement with EIDOS;

Whereas, the Parties desire to memorialize a prior transfer of the Fox Application in a form suitable for recording in the USPTO and in other applicable jurisdictions outside the United States;

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the Parties agree as follows:

Fox hereby sells, assigns, transfers and conveys to SEL the entire right, title, interest in and to the Fox Application in the United States and all jurisdictions outside the United States together with the goodwill of the business connected with, and symbolized by, the Fox Application including, without limitation, the right to renew any registrations, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Fox Application and any priority right that may arise from the Fox Application , including all causes of action as may have accrued on or before the date of this Assignment, the same to be held and enjoyed by SEL as fully and entirely as said interest could have been held and enjoyed by Fox had this sale, assignment, transfer and conveyance not been made.


