ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

This ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (this "Assignment"), dated as of March 7, 2019, is by MIDCAP FUNDING X TRUST, a Delaware statutory trust, acting in its capacity as the current and assigning administrative agent, as successor by assignment from MidCap Financial Trust (in such capacity, "MCFX"), MIDCAP FINANCIAL TRUST, a Delaware statutory trust ("MCF", and collectively with MCFX, the "Assigning Agent"), and MIDCAP FUNDING IV TRUST, a Delaware statutory trust, acting in its capacity as the successor administrative agent (in such capacity, the "Successor Agent").

RECITALS:

WHEREAS, AVAD LLC, a Delaware limited liability company, WAVE ELECTRONICS, INC., a Texas corporation, and MSTR BRAND, INC. (f/k/a MSTR BRAND, LLC), a Texas corporation (collectively, the "Grantors"), and MCF are parties to that certain Trademark Security Agreement dated as of October 2, 2018 and recorded with the United States Patent and Trademark Office on October 2, 2018 at Reel/Frame 6447/0924 (as amended, restated, supplemented or otherwise modified from time to time, the "Agreement") covering certain trademarks set forth on Schedule A attached hereto;

WHEREAS, on or about October 2, 2018, MCF has assigned to MCFX all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent; and

WHEREAS, pursuant to that certain Agency Assignment and Assumption dated as of February 13, 2019 between MCFX and the Successor Agent, MCFX has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent.

In consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assigning Agent hereby assigns and transfers to the Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreement.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


