**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**WHEREAS**, 8708975 Canada Inc. (the "**Debtor**"), a corporation incorporated under the laws of Canada with offices at 850 McCaffrey Street, Montreal, QC H4T 1N1 is the owner of the trademarks set forth in Exhibit 1, as well as the underlying goodwill of said trademarks (collectively, the "**Trademarks**");

**AND WHEREAS**, The Toronto-Dominion Bank (the "**Creditor**") with offices at 66 Wellington Street West, 39<sup>th</sup> Floor, Toronto, ON M5K 1A2 entered into a Moveable Hypothec with the Debtor dated September 13, 2012 and an intellectual property security agreement dated February 27, 2015 (collectively, the "**IP Security Agreements**") by which the Debtor agreed to grant to the Creditor a secured interest in the Trademarks and other certain property;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Creditor hereby releases and discharges its security interest in the Trademarks.


