RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of March 14, 2019, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** as Agent ("Secured Party").

WHEREAS, pursuant to that certain Trademark Collateral Assignment and Security Agreement, dated September 30, 2014 (the "Trademark Agreement") and **UNGER FABRIK, LLC**, a Delaware limited liability company ("Grantor") granted to Secured Party a security interest in certain Trademarks (as defined in the Trademark Agreement) and other Collateral (as defined in the Trademark Agreement) of the Grantor, which Trademarks are more fully identified on Schedule A annexed hereto and made a part hereof (the "Subject Trademarks").

WHEREAS, Secured Party's security interest was recorded with the United States Patent and Trademark Office ("USPTO") by Secured Party's filing of the Trademark Agreement which was recorded with the USPTO on October 26, 2018, at Reel/Frame 6468/0664.

NOW THEREFORE, Secured Party hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges the Trademark Agreement and Secured Party's security interest in, lien on, and conditional assignment of the Subject Trademarks and other Collateral and Secured Party hereby reassigns to the applicable Grantor any and all such right, title and interest (if any) that the Secured Party may have in the Subject Trademarks. Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Subject Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of California.
