RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “**Release**”) is made as of March 19, 2019, by Jason Stein, as agent (in such capacity, the “**Agent**”) for Jason Stein and Don Middleberg (the “**Noteholders**”), as holders of certain 5.00% secured notes due 2016 (the “**Notes**”), in favor of WASSERMAN MEDIA GROUP, LLC, a Delaware limited liability company (“**WMG**”), and WASSERMAN EVENTS LLC, a Delaware limited liability company (“**Wasserman Events**”, and collectively with WMG, the “**Grantors**”).

WHEREAS, pursuant to that certain Second Lien Guarantee and Security Agreement, dated as of April 15, 2015 (the “Security Agreement”), by the Grantors in favor of the Agent for the benefit of the Noteholders, the Grantors granted to the Agent, for the benefit of the Noteholders, a security interest in, among other property, certain intellectual property of the Grantors, and executed that certain Trademark Security Agreement, dated as of April 15, 2015 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on April 16, 2015, at Trademark Reel 005500, Frame 0786, pursuant to which the Grantors granted a security interest to the Agent, for the benefit of the Noteholders, in and to the trademarks specifically listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the “Marks”); and

WHEREAS, the indebtedness under the Notes has previously been paid and satisfied in full, and the Agent wishes to release, retransfer and reassign to the applicable Grantors, all of the Agent’s right, title and interest in and to the Marks and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. The Agent hereby releases to applicable Grantor, all of the Agent’s right, title and interest (including any security interests) in and to the Marks and the goodwill associated therewith.
2. If and to the extent that Agent has acquired any right, title or interest in or to any of the Marks or the goodwill associated therewith, the Agent hereby reassigns, grants and conveys to the applicable Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent’s right, title, and interest in and to the Marks, along with any goodwill in the Marks that the Agent may have acquired.
3. The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer or relevant governmental authority record this Release.



