**ASSIGNMENT OF TRADEMARK
AND ACCOMPANYING GOODWILL**

This ASSIGNMENT OF TRADEMARK AND ACCOMPANYING GOODWILL is made and effective as of the ~~01st~~ day of March, 2019 (hereinafter the "Effective Date"), by and between ASSA ABLOY Residential Group, Inc. ("hereinafter the Assignor") and ASSA ABLOY Access and Egress Hardware Group, Inc. ("hereinafter the Assignee"), as follows:

WHEREAS, Assignor, a California corporation, whose address is 15250 E. Stafford Street, City of Industry, California 91744, is the owner of the NEXTTOUCH trademark and the registration therefor in the United States Patent and Trademark Office, Registration No. 5697550 (the "Mark"), together with the goodwill of the business symbolized by such Mark, and any and all rights appurtenant to such Mark; and

WHEREAS, Assignee, a Delaware corporation, whose address is 225 Episcopal Road, Berlin, Connecticut 06037, is desirous of acquiring the Mark, and all goodwill associated therewith and symbolized thereby and all rights appurtenant thereto;

NOW, THEREFORE, in consideration of the sum of One and No/100 Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges by its execution below:

1. Assignor hereby assigns to Assignee, as of the Effective Date, all of its rights, title and interest in and to the Mark, together with the goodwill of the business associated therewith and symbolized thereby, and together with all rights appurtenant thereto, including without limitation (a) all common law rights therein, if any; (b) all licenses for the use of the Mark, if any; and (c) any and all interests, claims and causes of action with respect to any of the foregoing, whether accruing before, on or after the Effective Date hereof, including without limitation all rights to and claims for damages and profits, restitution and injunctive and other legal and equitable relief by reason of any past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default, unauthorized use

and all other related causes of action, with the right but not the obligation to sue for such legal and/or equitable relief and to collect, or otherwise recover, any such damages, related to the mark, all of the same to be held and enjoyed by Assignee as fully and entirely as the same would have been held by Assignor had this transfer and assignment not been made.

2. Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request of Assignee which may be required to transfer all of Assignor's rights, title and interest in and to the said Mark and/or the rights appurtenant thereto to Assignee, its successors or assigns.

3. Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office to issue any renewals for said trademark registration, when granted, to Assignee, its successors and assigns, and to record this Assignment.
